### **ABOUT ALAN SCHWARTZ (MHS 1970)**

Over the past 30 years Alan created, acquired, built, managed and sold a number of successful businesses in industries as diverse as publishing, software and professional services. In 2005 Alan sold his legal publishing and software business, Anstat Group, to an ASX listed company. Today Alan is the Managing Director of the Trawalla Group which he founded with his wife Carol.

Alan and his wife Carol Schwartz established the Trawalla Foundation in 2004 as a vehicle for the family's philanthropic activities. In recognition of his contribution to community and business, Alan was awarded a Centenary Medal in 2003, followed by an Order of Australia (AM) in 2007.

Alan graduated from Monash University with degrees in Economics and Law (Honours) and during his first year at Monash co-authored a best-selling economics textbook, The Australian Economy.

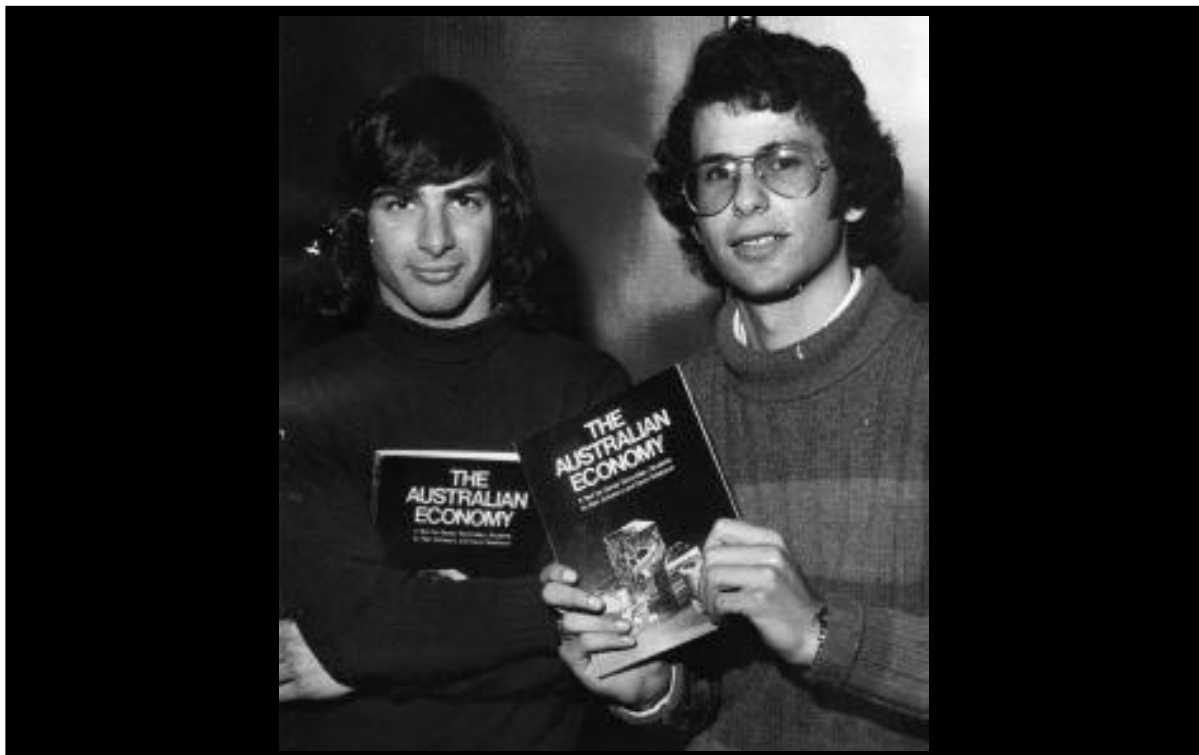
Alan is married to Carol, is the father of four magnificent children and six times a grandfather.

### ABOUT DAVID TEITELBAUM (MHS 1970)

From Melbourne High School, David completed an honours degree in Law and a degree in Economics at Monash University. During that period, he co-authored "The Australian Economy" published by Rigby Ltd.

After being admitted as a barrister and solicitor, he left for the United States for a role as creative director for a Los Angeles-based entertainment marketing firm. While in America, he launched a market research firm, Campus Opinion Inc., was a regular contributor to a variety of international publications and was U.S correspondent for radio stations throughout Australia. He also wrote "Rock 'n Roll Asylum" published by Delilah Publications, New York.

Upon returning to Australia, he established a marketing, advertising and business consultancy firm which has produced television commercials, corporate, government and educational videos, feature films and documentaries. He is also CEO of an affiliated speakers' bureau and celebrity management firm.

## THE ALAN SCHWARTZ & DAVID TEITELBAUM SCHOLARSHIP

- The Alan Schwartz & David Teitelbaum Scholarship consists of a payment of \$1,000 and is accompanied by a certificate with citation.
- One scholarship will be awarded each year.
- The scholarship will be awarded following receipt of written applications and interviews of shortlisted applicants.
- Previous recipients are not eligible to apply in subsequent years.

## CRITERIA

Applicants should:

- a. be a current student in Year 11 or Year 12 at Melbourne High School
- b. be undertaking studies in economics, business or related subjects
- c. demonstrate aspirations to tertiary studies and a career in economics, business or finance
- d. demonstrate outstanding academic results
